"I move that the additions and changes to the Articles of Incorporation be approved as presented, and that the committee be authorized to prepare the Articles of Amendment Form and submit it to the Secretary of the State of Washington for official filing." **Events:** Jeri Samuelsen reported the Fall Luncheon at the Seattle Yacht Club has been tentatively set for October 5<sup>th</sup>.
