**Minutes:** A motion was made by Roger Jensen and seconded by Maggie Birch / Claudia Lovgren to approve the minutes of the July 15, 2020 board meeting. All present members agreed.

**Treasurer's Finance Report:** L.D. Zobrist and Claudia Lovgren presented the Treasurer's report that was emailed to all board members.

This has been an eventful (eventless is more accurate) year. It has affected our operations and our cash flow significantly. A cash flow report that compares year-to-date results this year to last for our general operations was included in the email.

First, our donations to date are down by over \$7,500 from last year. We have been getting a steady stream of donations since the new KUAY issue, and last year was our best year ever; so that may not be a fair comparison.

Second, we have no events so no event revenue or expenses. No Scholarships have been awarded, so no checks have been written for that expense.

Finally, our normal expenses for printing, mailing, shipping, storage, etc., have increased some over last year which we will need to keep in mind when we create the 2021 budget.

We have just received about \$850.00 in grizzly gear inventory to replenish our stock that will show next month. Our funding reserve is adequate to compensate for our most unusual year.

**New Business:** After a brief discussion, it was decided that we need to cancel our Fall Homecoming Dance due to uncertainties about COVID-19. Jeanne made a motion to cancel the event and let the D.J. Ron Bolin keep the \$100.00 deposit, it was seconded by Claudia and approved by all members present.

Shirley will notify the D.J. of the cancellation and Jeanne will confirm with the Elks Club that we will NOT be having the event on Oct. 17, 2020. L.D. will email all Grizzlies with an update. We hope to dance again in 2021!
