The meeting was called to order by President, Sally Villaluz Ghormley at 7:08 P. M.

**Minutes:** A motion was made by Jeanne Warren and seconded by Maggie Birch to approve the minutes of the February 17, 2021 board meeting. All present members agreed.

**Treasurer's Finance Report:** L.D. Zobrist and Claudia Lovgren presented the Treasurer's report that was emailed to all board members:

Happy St. Patrick's Day! This month we will examine the General Operating Fund financial status. We have received revenue in the amount of \$6,638, mostly from donations and logo sales. Our expenses are from the production and mailing of the KUAY newsletter, plus shipping logo and bank fees for PayPal. Our net income is slightly less than break even. This means our revenue for this period mostly offset the cost of our newsletter, and much of the revenue is a result of the newsletter publication.

Our net worth for General Operating continues to be quite stable at \$65,589, giving us a nice reserve for our operations.

For this coming month, we plan on refilling our Logo inventory, which will increase our expenses for April. All Scholarship checks have been cashed by awardees.

Next month will be a review of cash flow compared to our budget for 1Q2021.

**Old Business:** Since we have quorum tonight, we will review and vote on whether or not to participate in "GiveBig WA" - Nonprofits 501c3's big event - in 2021. Now there is a \$20 annual fee to register to participate, it used to be free. Giving days will be May 4th & 5th. If we decide to be included in this program, we need to make our payment by April 20.

The board asked, how many donations do we get? Only one or two when we have participated in the past. The board asked, do we get a lot of publicity from this? Not really, the previous donors were already active alumni donators.

Maggie Birch made a motion that the QAHSAA not participate in GiveBig WA in 2021. Jeanne Warren seconded the motion. All present members agreed.

**New Business:** LD notified us that the QAHSAA has become eligible for Amazon Smile purchase donations.
